(Revenue \$) Youth Homes operates four, 6-bed, state-licensed Short Term Residential Therapeutic Programs for youth, ages 7-18, in various cities in Central Contra Costa County. All four of these programs provide intensive 24/7 care, enrichment activities such as garden program, or photography class and including a wide variety of mental health services including psychiatric assessment, individual and group therapy. The youth served in these programs have experienced significant trauma and are working on significant behavioral challenges which are barriers to them living in a family environment. Over 8,000 days of care were provided to 50 youth last year.

Resource Family Program: This program recruits, trains and approves

(Revenue \$) Family Pathways: This Youth Homes program provides intensive care coordination, therapy, and home based mental health services for foster youth with mental health challenges. This program works intensively with the child, or youth and their family, in a team-based approach with a focus on assuring adequate services and supports are available and provided in a coordinated basis, to allow foster youth to return to their family or live in a family setting.

Therapeutic Behavioral Services: Youth Homes provides very intensive individual, family based skill coaching, to alleviate severe behavioral challenges that would otherwise lead to children, and youth, being hospitalized or placed in residential treatment facilities. A highly

First, the Aftercare Program which provides mental health services for foster youth and former foster youth ages 17-21. Second, the Transition Age Youth Full Service Partnership which provides intensive case-management and mental health services for youth 16-26 with severe mental health issues. Lastly, Stepping Stones and the Resource Center which provides job coaching, employment placement, life skills workshops and education support for the young adults in all of our programs.
