
Our fiscal year

Despite challenges in occupancy and billing on the program side, we were proud to finish the fiscal year with a surplus. The final quarter marked the beginning of the COVID-19 pandemic, with large anticipated losses due to reduced billing and youth placements. Contra Costa County reimbursed at a double billing rate for Community Mental Health services in the last quarter of the fiscal year, which allowed us to close the year without losses.

The financial markets were negatively impacted by Covid-19, which showed in our lower than average income from investments.

CFO Jose Yanes represented our first dedicated resource for agency finances; his full-time focus allowed us to analyze and improve many systems, and also prioritize general financial health, program impact, and fiscal sustainability.
