## Dear Friends,

I am delighted to share insights and progress from this past year. Our impact on the community has been meaningful and broad and is a result of the staggering support from all of you! I am both grateful and humbled by your support for Youth Homes and the community that we serve.

As the state of California continues to make changes to its child welfare services program as mandated by the Continuum of Care Reform (CCR), Youth Homes, as required by CCR, has made progress to transition our group homes into Short Term Residential Therapeutic Programs (STRTP). This new framework ensures youth spend a minimum of time in residential care and move quickly into a stable family environment.

A decade ago, Youth Homes had the foresight to see that these changes were on the horizon; therefore, we took steps to lay groundwork to be ready once CCR was rolled out. We began by securing a mental health contract which allows us to deliver mental health services that our youth and families need as part of a continuum of care. We then became nationally accredited. Achieving these milestones allowed for Youth Homes to become one of the first agencies in Contra Costa County to begin the transition to STRTPs.

Youth Homes will continue to be the leading residential care provider in Contra Costa County, currently serving

**FOSTER YOUTH IN** RESIDENTIAL CARE. CCR has also impacted our Foster Family Agency, which was re-envisioned as a Resource Family Program (RFP) that focuses on recruiting foster parents, relative caregivers, and pre-adoptive families—all of whom are willing to open their homes and hearts to our youth. Critical to RFP is the building of adult connections to help expand a youth's options for potential resource families and lifelong connections.

As our own continuum of care grew, we saw the need to improve the coordination of care and efficiency of the services we provide. This, along with the importance of protecting our clients' data, led us to implement an Electronic Health Record. Over the past year we have made significant strides on this project that will ultimately empower our clients to be more involved in their care by having greater accessibility.

I am proud and impressed with the agility demonstrated by the Youth Homes team as they embraced and acted upon these changes—our team is truly remarkable! All of us are grateful for you, our community of supporters and ambassadors of hope. It is your commitment to our youth that has helped us to remain focused and strong. resource= THE NEW FOSTER


#### **OUR FISCAL YEAR**


As Youth Homes' expenses have increased over the years, we are now experiencing a period in which our cost of doing business has exceeded the reimbursement rates that have been in place for many years. This has caused concern for us, as well as our peer organizations. Although this is a consistent flow of critical revenue, it has not adjusted for the increase in expenses related to the comprehensive therapeutic care we provide.

Additionally, the annual rate increases do not account for regular inflation rates and the evergrowing increases of the cost of implementing quality and/or evidence-based services. Youth Homes is actively engaged in conversations regarding how to best address these concerns while also assessing

our own service delivery models.
